Terms and Conditions for Oral Health Practitioner Diploma by Freshly Minted Training

1. General Terms and Conditions

1.1 Enrolment: By enrolling in the training course offered by "Freshly Minted Training", you agree to abide by these terms and conditions.

1.4 Tuition methods: This is a six-month course starting on January 2024. You will learn through a mixture of online learning and practical mock clinical sessions in Glasgow. Your online modules will give you an in depth understanding of oral health, and will be released each month, with a test at the end of each module to confirm your knowledge. You will be assigned with one clinical coach to help you through the course.

2. Data Protection

3. Payment

3.2 Payment Plans over three instalments: If you choose to pay for the Course through a payment plan, payment links will be sent to you in due course: 1^{st} payment link of £216 is sent upon signing up the course (completing this application form), 2^{nd} payment link of £216 is sent 10/02/2024, and the third payment link is sent on 20/04/2024.

3.3 Payment Due Date: Payment reminders and links will be sent to your registered email address. Payment is due within 7 days of sending the payment reminder email by "Freshly Minted Training". Failure to make timely payments may result in your removal from the Course.

3.4 Refunds: You may request a refund by writing to <u>freshlyminted@outlook.com</u>. Refunds are subject to the following conditions:

a. 100% of the fees paid to date will be refunded after deducting £30 administrative fees if the refund request is made on and before 5th December, 2023.

b. 50% of the fees paid to date will be refunded if the refund request is made between 6th December, 2023 and 1st January, 2024.

4.2 Changes to Training Dates: "Freshly Minted Training" reserves the right to change the training dates at its discretion. Any changes will be communicated to you with advanced notification.

4.3 Attendance Requirement: To successfully complete the Course, you are required to attend all four practical, in-person training days. Failure to meet this requirement may result in your inability to finish the Course.
